TIMES AND LOCATION:

The jubilee will be held in downtown Clanton, Alabama around the courthouse square.

* Set-up will be that afternoon beginning at approximately 3:00pm. We ask you that you do not set-up until that approximate time.

* Take down is scheduled from 11:00pm to 12:00am. Exhibitors should remain open during the entire duration of the jubilee. If an exhibitor leaves before closing, they will not be invited to future jubilees. A determination of canceling the Jubilee in case of bad weather will be announced by noon on the 25th. No refunds will be given.

ENTRY:

An exhibitor is any individual, club, non-profit organization, church or business.

* No re-sale of booth space by an exhibitor is allowed. If the person whose application is accepted is unable to attend, the space reverts to the Peach Jam Jubilee Committee.

* Entry fees per space are **\$55.00 without electricity** and **\$65.00 with electricity**, Chilton County Chamber of Commerce members will need to contact the Chamber office to discuss a special Chamber rate. Entry fees must be submitted with application by May 31, 2010. Cancellations will be accepted prior to April 20, 2010; money will not be refunded for cancellations received after April 21, 2010.

*** IN ORDER TO BE CONSIDERED AS AN EXHIBITOR A PICTURE AND A FULL DESCRIPTION OF YOUR BOOTH MUST ACCOMPANY YOUR APPLICATION, A COMMITTEE WILL REVIEW ALL APPLICATIONS. ALL DECISIONS MADE BY THE COMMITTEE ARE FINAL.**

* Any booth or activity deemed inappropriate for the jubilee by the Peach Jam Jubilee Committee will be asked to leave.

FOOD:

Food vendors must contact the Health Department for permit, 205.755.1287. A valid food permit from the Health Department must be displayed. **You must send us a copy of the permit prior to the festival. Electric hook-ups will be available.**

*** Peach Jam Jubilee has exclusive rights for soft drinks and water, no vendor may sell or distribute soft drinks or water. Vendors may sell tea, coffee, smoothies, etc. If you have not paid for electricity but you are found using electricity, you will be escorted out immediately. No generators are allowed because of safety purposes. Please specify if you need more power than 110 wattage.**

SPACE:

* Booth spaces are approximately 10 x 10. Should your booth be larger than 10 x 10 you will need to rent the extra booth space, no exceptions will be made.

PROMOTION:

* Peach Jam Jubilee Committee will advertise over a period of several months in local, state and regional magazines, newspapers, radio and television.
